# The Canadian Association of Bariatric Physicians and Surgeons

### Active Member

A person who:

- (a) Is a medical practitioner and holds a valid certificate in medicine or surgery with a certificate in good standing from:
  - The Royal College of Physicians and Surgeons of Canada; or
  - Le Collège des Médecins du Québec; or
  - The American Board of Medicine or Surgery; or
  - The equivalent thereof acceptable to the Board of Directors, such equivalency must include significant training in general surgery and eligibility for, or possession of, a surgical diploma from some other jurisdiction;
  - and has some special interest and training in the treatment of obesity and severe obesity;

(b) Holds a valid license in good standing to practice medicine in Canada;

May apply for active membership in this Association. Active Members shall pay all dues and assessments.

### Associate Member

A person who:

Is a post-graduate trainee, currently enrolled in a training program related to the treatment of obesity and severe obesity (e.g. residents and fellows).

- Medical Doctors
  (Anethesiologists, Gastroentologists, Emergency Medicine, Critical Care, Others)
- · Medical Students in Canadian Medical Schools;
- a) Accredited by the Liaison Committee on Medical Education (LCME);
- b) The Department Chair or General Surgery Program Director must sign the application; and
- c) The Department Chair or General Surgery Program Director must submit an accompanying letter verifying that the applicant is a student in good standing in the medical school at the time of application.
- d) Is a retired medical practitioner who has held a valid certificate in general medicine or surgery and has been an active member for at least 5 years.

Associate members shall pay applicable member dues and assessments and shall not be eligible for voting privileges and shall not be eligible to hold office in the Association.



## Affiliate Members

Any person belonging to the following classification may be admitted as an Affiliate Member following approval by the CABPS Board of Directors:

- Non-Medical Doctors Masters Degree Scientists and PhDs Scientists
